Fees Advice and Payment Instructions

In order to meet Karilee's running costs, fees are collected in three instalments. **We require the payment of the Calisthenics ACT registration fee and the first fee payment by Friday, 08 February 2019.** Karilee's preferred payment method is by direct debit by the due date. You can also pay your fees progressively throughout the year by setting up regular payments from your bank account.

Karilee can accept debit and credit card payments although there is a 1.9% or 2.2% bank fee to use this facility. A statement showing your payments and any outstanding debt will be emailed to you in March/April.

Karilee fees DO COVER class costs (tuition and hall hire), costumes and competition costs. The annual Cali-ACT registration fee is a compulsory fee levied by our State association. This covers participants for insurance through the year. The Ballarat trip is an interstate competition which usually occurs in October. Trip costs differ from year to year depending on team requirements and the actual trip balance is calculated once the trip costs have been reconciled. Various options are available to reduce Ballarat costs** (e.g. driving vs flying); please discuss options with your Team Manager.

Karilee fees DO NOT COVER additional items which may incur costs during the year such as clubs, rods, practice skirts, flesh-coloured high cut underwear, uniform items, some make-up and hair items, wigs and expenses related to social activities and non-participants interstate competition costs.

ALL FEES are due by the dates stated above unless a payment plan approved by the Treasurer is in place. Any significant debt outstanding at 31st December will result in recovery action being taken. Where debts have been previously outstanding/or recovery action has needed to be taken, the family will be required to pay 50% of annual fees at the time of registration for the new calisthenics year. No participant will be declared financial for solo registration unless fees are entirely up to date.
